Egg Drop

Egg Drop (Encounter Church) - adding more times (i.e. tickets), several slots for smaller #s, helicopter, inflatables and activities (ex. Rock wall). GOULD PARK

Gould Park Budget for landscape/hardscape - neighborhood group wants us to request \$100k to do this work (plan by Activitas). They are fundraising \$300k for the statue. They submitted a plan for us to review.

- a. Issues: plan is too preliminary and broad, lot of money to ask for a project we didn't lead and we have other priorities at this time
- b. They should ask Town Meeting for the funds. Our understanding was that they would fundraise to complete the Park.
- c. Need a representative from the group to answer our questions.

DOG PARK

Dog Park Committee - 1 member is resigning, and they want to add 2 additional people (6 total members). We will post for 3 open positions. 10 days once posted.

TRENTON STREET PLAYGROUND

Trenton Park Playground MOU - we are looking to amend this document to increase Selectboard responsibility regarding notice, funds etc.; need more information regarding who is responsible for repair and replacement of equipment (much of which is very expensive) - looking for joint responsibility.

We are getting \$5k in the budget to maintain.

Commissioner Farnham will re-draft and I will help review. Will vote next time.

SIGN / PERMIT POLICIES

Need a separate document for sign requests and add language to the field permit request document regarding the need for sign permits. Approved making these changes. Field Policy - small changes approved. Tracey will share with all youth groups and put on website (sign policy as well).

DYS REQUESTS

Commissioner Farnham brought these concerns to the Board. They want the fence at Rustcraft to remain open (as was in 2021, want us to re-bid and get money back for the Needham Bank signage and turf on Rustcraft.

Issues with turfing because it is a multi-use baseball / soccer field. Master Plan's top priority was baseball fields and baseball may need a larger field as well. Need all affected youth groups to come before the board before we can decide this issue.
